
My position consists of managing the calendar of the President and CEO as well as managing all of the EDC's operations, I continue to work closely with everyone, from the front desk to




The biggest misconception is that there are no resources for small businesses. We have several business incubators in the county including our Innovation Station, Bowie BIC and Flavors Culinary Kitchen. In addition, we have several resource partners who provide business mentoring along with our own Pathways business series who supports entrepreneurship by creating a pipeline of future business owners in targeted industries through technical assistance training.

Some of the key projects I've worked on in the county is the Target Distribution Campus in Upper Marlboro, the expansion of Ruby's Southern Kitchen in Bowie and the attraction of Huncho House in Hyattsville.

We are expanding businesses in Prince Georges County Maryland by providing valuable resource assistance. Our office provides site selection assistance, demographic information, permitting assistance and county resources. My work at the EDC Division of Business Development is focused on business retention, expansion, and attraction with a particular focus on the federal government sector. I stay plugged into the business and federal government community locally and beyond via an active business visitation program, market intelligence tools like CoStar, Hoovers and EZGovOpps, and connections with the business development eco-system that includes government entities like local incorporated municipalities, Maryland state agencies and federal agencies, and private sector entities like commercial industry developers and brokers, chambers of commerce and industry associations.

For me business development is the retention and growth of employers in the local economy and attraction of new employers. This includes for-profit and non-profit businesses and federal government agencies. By employers increasing their commercial investments in the county such as from their leasing, purchasing or expanding of commercial real estate properties, they grow the amount of taxes the county receives from commercial activity. And this is the part of the economy that the county needs most to expand because employers (and businesses in particular) consume much less of county resources for each dollar of local taxes

paid than is consumed by homeowners for each residential tax dollar paid. Increasing receipt of taxes more than expenditures provides the extra funding needed to afford an improved quality of life for county residents with more local employment opportunities, better schools, better roads, etc.



#### ANDRE PLUMMER

My name is Andre Plummer, and I am a finance professional possessing more than 18 years of experience, including 7+ years of alternative financial analytics and underwriting expertise. My experience brings a broad range of commercial lending and underwriting competencies. My role at The Prince Georges County Economic Development Corporation is multi-faceted. Primarily,

I assist Prince Georges County businesses with realizing specific tax credits or incentives that may be applicable to their "projects". In addition. I would instead say that I help businesses uncover potential aid and assistance to their already existing

operations or strategic plans. For example, there a many industries we would like to attract to the county, such as information technology, research and development, hospitals and health services and federal government. These industry sectors are important to Prince Georges County's economy, as they provide growth in county jobs,
